(17:02) Moving the SHUG-EC Meeting Time

(17:03) 'Collaboration Agreement' Wording

- Ben's text: "If you were recently awarded beam time, you may have noticed a new section of the award letter called the "Collaboration Agreement". If your collaboration or intended coauthor list involves any of the organizations on the screening list, please reach out to the user office at neutronusers@ornl.gov to discuss options for carrying out your experiment."
- The SHUG-EC and Jon have approved the wording on the basis that it represents the policy well and encourages the users to carefully read the agreement and contact the user office if there are any questions/concerns.

(17:05) Scheduling the STS Webinar

- The webinar is so far planned to run for 90 minutes.

(17:21) SHUG-EC On-Site Meeting Agenda

- The SHUG-EC worked together to fill out and organize the agenda draft, with some of the major updates being:
